This brochure is designed to provide the public with information and a summary of regulations pertaining to hunting and other recreational use on the Econfina Creek Wildlife Management Area. **Regulations that are new or differ substantially from last year are shown in bold print.** Area users should familiarize themselves with all regulations. For exact wording of the wildlife laws and regulations, see the Florida Fish and Wildlife Conservation Commission's wildlife code, on file with the Secretary of State and state libraries. This brochure, the Florida Hunting Regulations handbook, and quota permit worksheets should provide the information necessary for you to plan your hunting activities. These publications are available from any Commission office, county tax collector and at [MyFWC.com](http://MyFWC.com).

Persons using wildlife management areas are required to have appropriate licenses, permits and stamps. The following persons are exempt from all license and permit requirements (except for quota permits when listed as "no exemptions", recreational use permits, antlerless deer permits and the Migratory Bird Hunting and Conservation Stamp [federal duck stamp]): Florida residents who are 65 years of age or older; residents who possess a Florida Resident Disabled Person Hunting and Fishing Certificate; residents in the U.S. Armed Forces, not stationed in Florida, while home on leave for 30 days or less, upon submission of orders; and children under 16 years of age. Children under 16 years of age are exempt from the duck stamp. Anyone born on or after June 1, 1975 and 16 years of age or older must have passed a Commission-approved hunter-safety course prior to being issued a hunting license, except the Hunter Safety Mentoring exemption allows anyone to purchase a hunting license and hunt under the supervision of a licensed hunter, 21 years of age or older, for one year.

Licenses and permits may be purchased from county tax collectors, license agents, at [MyFWC.com/license](http://MyFWC.com/license) or by telephone at 1-888-486-8356. A no-cost Migratory Bird Permit is available when purchasing a hunting license. Any waterfowl hunter 16 years of age or older must possess a federal duck stamp; available where hunting licenses are sold, at most post offices or at [duckstamp.com](http://duckstamp.com). Mobility-impaired certificate applications are available from regional offices of the Commission and at [MyFWC.com](http://MyFWC.com).

### QUOTA PERMIT INFORMATION:

- Archery (Cat Creek area) - 30, no-cost, quota permits for each of 2 hunts.
- Archery (Fitzhugh Carter area) - 15, no-cost, quota permits (no exemptions) for each of 2 hunts.
- Muzzleloading Gun (Cat Creek area) - 30, no-cost, quota permits.
- Muzzleloading Gun (Fitzhugh Carter area) - 15, no-cost, quota permits (no exemptions).
- General Gun (still hunt area, first 13 days) - 50, no-cost, quota permits.
- General Gun (dog hunt area) - 80, no-cost, quota permits.
- General Gun (Cat Creek area) - 30, no-cost, quota permits for each of 3 hunts.
- General Gun (Fitzhugh Carter area) - 15, no-cost, quota permits (no exemptions) for each of 3 hunts.
- Mobility-impaired General Gun - 20, no-cost, quota permits (no exemptions) for each of 5 hunts.
- Spring Turkey (still hunt and dog hunt areas, first 9 days) - 25, no-cost, quota permits.
- Spring Turkey (Cat Creek area) - 5, no-cost, quota permits for each of 3 hunts.
- Spring Turkey (Fitzhugh Carter area) - 5, no-cost, quota permits (no exemptions) for each of 3 hunts.
- Youth Turkey (still hunt and dog hunt areas) - 10, no-cost, quota permits (no exemptions).

**Youth Turkey (Cat Creek area) - 3, no-cost, quota permits (no exemptions).**

**Youth Turkey (Fitzhugh Carter area) - 3, no-cost, quota permits (no exemptions).**

Permit applications: Hunters must submit electronic applications for quota and special-opportunity permits through the Commission's Total Licensing System (TLS). Worksheets listing hunts, application periods, deadlines and instructions are available at county tax collector's offices, FWC offices or [MyFWC.com](http://MyFWC.com). Quota application periods occur throughout the year beginning April 1; please refer to the hunting handbook or [MyFWC.com](http://MyFWC.com) for specific dates. Worksheets will be available about 2 weeks prior to each application period.

Guest hunters: For each non-transferable archery, muzzleloading gun, general gun, wild hog, spring turkey and mobility-impaired quota permit issued through the Commission's TLS, only one guest permit may be obtained. Guest permits are not issued for youth turkey quota permits. The following persons may be a guest hunter, but are not required to obtain a guest permit: a youth under 16 years of age, a youth supervisor, a mentor license holder or a mentor license supervisor. A quota permit holder (host) may only bring 1 guest hunter at a time. The following persons are not considered to be guest hunters: other quota permit holders, non-hunters and exempt hunters (on areas and during seasons that allow exemptions). The host must share the bag limit with the guest and the host is responsible for violations that exceed the bag limit. The guest and host must enter and exit the area together and must share a street-legal vehicle while hunting on the area. The guest may only hunt while the host is on the area. A person is only eligible for one guest permit per hunt. Guest permits may only be obtained from license agents or county tax collector's offices. Guest permits may be obtained up to and during the last day of the hunt. Refer to the quota hunt worksheets for additional information.

Youth and mentor license holders: A youth hunter (less than 16 years of age) must be supervised by a person at least 18 years of age. A mentor license holder must be supervised by a licensed hunter at least 21 years of age. Unless exempt, only those supervisors with proper licenses and permits may hunt. If the supervisor is hunting during any hunt (not including special-opportunity) for which quota permits are issued, at least one person in the party must be in possession of a quota permit. During a hunt that allows exemptions, a non-exempt supervisor of a youth must have a quota permit to hunt. A non-hunting supervisor is allowed to accompany a youth or mentor license holder during any hunt (including special-opportunity).

Assistant for mobility-impaired hunters: Mobility-impaired hunters may be accompanied by a guest hunter, as specified above, and one non-hunting assistant that may participate in the hunt (no license required), but the assistant may not harvest wildlife with archery equipment or a firearm.

Transfer of permits: Quota and guest permits are not transferable. Except for youth under 16 years of age, a positive form of identification is required when using a non-transferable permit. The sale or purchase of any quota permit or guest permit is prohibited.

### GENERAL AREA REGULATIONS:

All general laws and regulations relating to wildlife and fish shall apply unless specifically exempted for this area. Hunting or the taking of wildlife or fish on this area shall be allowed only during the open seasons and in accordance with the following regulations:

- Any person hunting deer or accompanying another person hunting deer shall wear at least 500 square inches of daylight fluorescent-orange material as an outer garment, above the waistline. These provisions are not required when hunting with a bow and arrow during archery season.
- Taking of spotted fawn, swimming deer or roasted turkey is prohibited. Species legal to hunt are listed under each season.
- It is illegal to hunt over bait or place any bait or other food for wildlife on this area.
- Driving a metal object into any tree, or hunting from a tree into which a metal object has been driven, is prohibited.
- No person shall cut, damage or remove any natural, man-made or cultural resource without written authorization of the landowner or primary land manager.
- Taking or attempting to take any game with the aid of live decoys, recorded game calls or sounds, set guns, artificial light, net, trap, snare, drug or poison is prohibited. Recorded calls and sounds can be used to hunt furbearers, wild hog and crows.
- The wanton and willful waste of wildlife is prohibited.
- Hunting, fishing or trapping is prohibited on any portion of the area posted as closed to those activities.
- People, dogs, vehicles and other recreational equipment are prohibited in areas posted as "Closed to Public Access" by FWC administrative action.
- Taking or herding wildlife from any motorized vehicle, aircraft or boat, which is under power is prohibited until power, and movement from that power, has ceased.
- Most game may be hunted from ½ hour before sunrise until ½ hour after sunset (see exceptions for each season).
- The release of any animal is prohibited, without written authorization of the landowner or primary land manager.
- The head and evidence of sex may not be removed from the carcass of any deer or turkey on the area.
- The planting or introduction of any non-native plant is prohibited, without written authorization of the landowner or primary land manager.
- Wild hog may not be transported alive.
- Littering is prohibited.
- It is unlawful to set fire to any forest, grass or woodlands.
- A Fish and Wildlife Conservation Commission Law Enforcement Officer may search any camp, vehicle or boat in accordance with law.
- Falconers may hunt during the statewide falconry season anytime a management area is open for public access. Falconers are not exempt from quota permits during hunts requiring them.
- The possession or consumption of intoxicating beverages is prohibited.
- For hunting non-migratory game, only shotguns, rifles, pistols, bows, crossbows or falconry may be used. **Hunting during the spring turkey season with firearms other than shotguns or using a shot size larger than #2 is prohibited.**
- For hunting migratory game, only shotguns, bows, crossbows or falconry may be used. Shotguns shall not be larger than 10 gauge and shall be incapable of holding more than three shells in the magazine and chamber combined.
- Firearms using rimfire or non-expanding, full metal jacket (military ball) ammunition are prohibited for taking deer.
- Fully automatic or silencer-equipped firearms, centerfire semi-automatic rifles having a magazine capable of holding more than five rounds, explosive or drug-injecting devices and set guns are prohibited.

#### DOGS:

- Hunting with dogs, other than bird dogs or retrievers, is prohibited in the designated still hunt, Cat Creek, Fitzhugh Carter and mobility-impaired areas, except dogs may be used to hunt raccoons (except in the mobility-impaired areas).
- No person shall allow any dog to pursue or molest any wildlife during any period in which the taking of wildlife by the use of dogs is prohibited.
- Dogs on leashes may be used for trailing wounded game.
- For purposes other than hunting, dogs are allowed, but must be kept under physical restraint at all times.

#### CAMPING:

Camping is allowed only at designated sites for no more than 14 consecutive days at a time or by permit from the Northwest Florida Water Management District (850) 539-5999.

**BAG AND POSSESSION LIMITS:** During quota hunts, host hunters and guests must share all bag and possession limits.

- Deer - Daily limit 2, possession limit 4 (see legal to take for each season).
- Wild hog - No size or bag limit.
- Turkey - Daily limit 1, season limit 2, possession limit 2; **youth turkey, 1 per quota permit.**
- Gray squirrel, quail and rabbit - Daily limit 12, possession limit 24 for each.
- Raccoon, opossum, armadillo, beaver, coyote, skunk and nutria - No bag limits.
- Bobcat and otter - Possession limit 1 unless in possession of a Trapping License.
- Migratory birds - See Migratory Bird Hunting Regulations pamphlet.

#### ARCHERY SEASON:

**October 22 through November 20** (except in the Cat Creek, Fitzhugh Carter and mobility-impaired areas).

**October 22-28 and October 29 through November 6** (Cat Creek and Fitzhugh Carter areas).

Permit, Stamp and License Requirements - Quota permit (if hunting in the Cat Creek or Fitzhugh Carter areas), hunting license, management area permit, archery permit, deer permit (if hunting deer), wild turkey permit (if hunting wild turkey) and migratory bird permit (if hunting migratory birds).

Legal to Hunt - Any deer (except spotted fawn), wild hog, turkey of either sex, gray squirrel, quail, rabbit, raccoon, opossum, armadillo, beaver, coyote, skunk, nutria and migratory birds in season.

Regulations Unique to Archery Season - In addition to these regulations, all General Area Regulations shall apply.

- Hunting with firearms or crossbows (except by disabled crossbow permit) is prohibited, except that centerfire shotguns are allowed for hunting small game during the small game season and for hunting migratory birds when one or more species are legal to hunt (see Migratory Bird section and the current Migratory Bird Hunting Regulations pamphlet).
- Hunting is prohibited in the mobility-impaired area.

#### SMALL GAME SEASON:

**November 12 through March 4** (except in the Cat Creek, Fitzhugh Carter and mobility-impaired areas).

**December 10-25** (Cat Creek and Fitzhugh Carter areas).

Permit, Stamp and License Requirements - Quota permit (if hunting during any quota period), hunting license, management area permit, migratory bird permit (if hunting migratory birds) and state waterfowl permit and federal duck stamp (if hunting waterfowl).

Legal to Hunt - Wild hog, gray squirrel, quail, rabbit, raccoon, opossum, armadillo, beaver, coyote, skunk, nutria and migratory birds in season. Bobcat and otter December 1 through March 1.

Regulations Unique to Small Game Season - In addition to these regulations, all General Area Regulations shall apply.

- Hunting with centerfire rifles is prohibited, except during general gun season.
- Hunting is prohibited in the mobility-impaired area.

#### GENERAL GUN SEASON:

**November 24-27 and December 10 through February 1** (except in the Cat Creek, Fitzhugh Carter and mobility-impaired areas).

**November 24-27, January 21-24 and 25-29** (Cat Creek and Fitzhugh Carter areas).

**November 25-27, January 13-15, 20-22, 27-29 and February 1-3** (mobility-impaired area).

Permit, Stamp and License Requirements - Quota permit (if hunting in the Cat Creek, Fitzhugh Carter, mobility-impaired or dog hunt areas and if hunting before December 19 in the still hunt area), hunting license, management area permit, deer

#### PUBLIC ACCESS AND VEHICLES:

- Open to public access year round.
- All persons entering or exiting the Fitzhugh Carter area may do so only at a designated entrance (see map).
- During periods open to hunting, vehicles may be operated only on named or numbered roads except in the mobility-impaired hunt area. During periods open to hunting in the mobility-impaired hunt area, vehicles may be operated only by persons participating in the hunt. During periods closed to hunting, vehicular access is prohibited on dog roads 1-8, 10, 13-17, 19-28 and 33-37, Einfinger Road and numbered roads in the mobility-impaired area. Detailed maps of dog roads and the mobility-impaired area are available at [nwfwm/recreation/econfinacreek.html](http://nwfwm/recreation/econfinacreek.html).
- Parked vehicles may not obstruct a road, gate or firelane.
- No motor vehicle shall be operated on any part of any wildlife management area that has been designated as closed to vehicular traffic.
- The use of all-terrain vehicles is prohibited except in the mobility-impaired area by persons possessing mobility-impaired certificates.
- Horses are allowed on designated horse trails only; horses and the use of bicycles are prohibited in the Fitzhugh Carter area.
- A marked footpath called the Florida Trail traverses the area. This trail is open to hikers throughout the year.

#### HUNTERS AND CHECK STATIONS:

- Hunters shall check in and out at the check station when entering and exiting the Fitzhugh Carter area and shall check all game taken.
- Hunting equipment and dogs may be taken onto the WMA after 8 a.m. the day before the opening of a season and shall be removed by 6 p.m. one day after the end of the season.

#### GUNS:

- All firearms shall be securely encased and in a vehicle, vessel, camper or tent, during periods when they are not a legal method of take. Persons in possession of a valid Concealed Weapon or Firearm License may carry concealed handguns.
- Target practice is prohibited.
- Hunting wildlife by use of a gun on or from rights-of-way of Thomas, Rattlesnake, Strickland, Porter Pond, Duma Jack/Deadening, Greenhead, Cat Creek and Einfinger Roads, Hampshire Boulevard, S.R. 20 or C.R. 388 is prohibited.
- Hunting with a gun and light is prohibited (see exception for the raccoon season).
- Muzzleloading guns used for taking deer must be .40 caliber or larger if firing a single bullet, or be 20 gauge or larger if firing two or more balls.
- Children under the age of 16 may not be in possession of a firearm unless in the presence of a supervising adult.
- No person shall have a gun under control while under the influence of alcohol or drugs.

permit (if hunting deer), migratory bird permit (if hunting migratory birds) and state waterfowl permit and federal duck stamp (if hunting waterfowl).

**Legal to Hunt** - Deer with at least one antler 5 inches or more in length, antlerless deer (which includes does and bucks with antlers less than 5 inches in length, but not spotted fawns) in the mobility-impaired area by mobility-impaired hunters only (limit 2 per quota permit; daily limit 1), wild hog, gray squirrel, quail, rabbit, raccoon, opossum, armadillo, beaver, coyote, skunk, nutria and migratory birds in season. Bobcat and otter beginning December 1.

**Regulations Unique to General Gun Season** - In addition to these regulations, all General Area Regulations shall apply. Only mobility-impaired hunters may take antlerless deer.

#### **MUZZLELOADING GUN SEASON:**

**December 3-5** (except in the mobility-impaired area).

**Permit, Stamp and License Requirements** - Quota permit (if hunting in the Cat Creek or Fitzhugh Carter areas), hunting license, management area permit, muzzleloading gun permit, deer permit (if hunting deer) and migratory bird permit (if hunting migratory birds).

**Legal to Hunt** - Deer with at least one antler 5 inches or more in length, wild hog, gray squirrel, quail, rabbit, raccoon, opossum, armadillo, beaver, coyote, skunk, nutria, bobcat, otter and migratory birds in season.

**Regulations Unique to Muzzleloading Gun Season** - In addition to these regulations, all General Area Regulations shall apply.

1. Hunting with archery equipment or firearms, other than muzzleloading guns, is prohibited, except that centerfire shotguns are allowed for hunting small game during the small game season and for hunting migratory birds when one or more species are legal to hunt (see Migratory Bird section and the current Migratory Bird Hunting Regulations pamphlet).
2. Hunting is prohibited in the mobility-impaired area.

#### **ARCHERY/MUZZLELOADING GUN SEASON:**

**February 2-12** (except in the Cat Creek, Fitzhugh Carter and mobility-impaired areas).

**Permit, Stamp and License Requirements** - Hunting license, management area permit, archery permit (if hunting with archery equipment), muzzleloading gun permit (if hunting with a muzzleloading gun), deer permit (if hunting deer) and migratory bird permit (if hunting migratory birds).

**Legal to Hunt** - Deer with at least one antler 5 inches or more in length, wild hog, gray squirrel, quail, rabbit, raccoon, opossum, armadillo, beaver, coyote, skunk, nutria, bobcat, otter and migratory birds in season.

**Regulations Unique to Archery/Muzzleloading Gun Season** - In addition to these regulations, all General Area Regulations shall apply. Hunting with crossbows (except by disabled crossbow permit) or firearms (except muzzleloading guns) is prohibited, except that centerfire shotguns are allowed for hunting small game during the small game season and for hunting migratory birds when one or more species are legal to hunt (see Migratory Bird section and the current Migratory Bird Hunting Regulations pamphlet).

#### **SPRING TURKEY SEASON:**

**Youth Turkey: March 10-11** (except in the mobility-impaired area).

**Spring Turkey: March 17 through April 22** (except in the Cat Creek, Fitzhugh Carter and mobility-impaired areas).

**March 17-19, March 30 through April 1 and April 13-15** (Cat Creek and Fitzhugh Carter areas).

**March 17-18, 23-25, March 30 through April 1, April 6-8, 13-15 and 20-22** (mobility-impaired area).

**Permit, Stamp and License Requirements** - Quota permit (if hunting in the Cat Creek or Fitzhugh Carter areas or before March 26 in the remainder of the area), mobility-impaired certificate (if hunting in the mobility-impaired area unless accompanying a person possessing a mobility-impaired certificate), hunting license, management area permit and wild turkey permit.

**Legal to Hunt** - Bearded turkey or gobbler.

**Regulations Unique to Spring Turkey Season** - In addition to these regulations, all General Area Regulations shall apply.

1. Legal shooting hours are ½ hour before sunrise until 1 p.m.
2. Hunting other animals is prohibited.
3. **Hunting with firearms other than shotguns or using a shot size larger than #2 is prohibited.**
4. **During the youth turkey hunt, only youth under 16 years of age may hunt and must be under the supervision and in the presence of an adult not younger than 18 years of age. Adults with required licenses and permits for taking wild turkeys may participate when in the presence of a youth, but may not harvest a wild turkey.**

#### **RACCOON SEASON:**

**November 12 through March 9 and April 23 through July 31** (except in the Cat Creek, Fitzhugh Carter and mobility-impaired areas).

**Permit, Stamp and License Requirements** - Quota permit (if hunting during the quota hunt period of the general gun season), hunting license and management area permit.

**Legal to Hunt** - Raccoon.

**Regulations Unique to Raccoon Season** - In addition to these regulations, all General Area Regulations shall apply. Raccoon may be taken at night by the aid of a light and dogs, with .22 rimfire firearms other than .22 magnum, or with a single-shot .410 gauge shotgun using shot no larger than No. 6 provided that no firearm shall be

loaded at any time except immediately prior to shooting of a treed or bayed raccoon. The hunting of raccoon by display or use of a light from a moving vehicle, boat or animal is prohibited.

**TRAPPING:** Prohibited.

#### **MIGRATORY BIRD SEASONS:**

Rails, common moorhen, mourning dove, white-winged dove, snipe, duck, geese, coot, woodcock and crows may be hunted during seasons established by the Commission for these species except in the Cat Creek, Fitzhugh Carter and mobility-impaired areas, where these species may be hunted only during seasons that coincide with the archery, muzzleloading gun, general gun or small game seasons. Waterfowl may be hunted on the Fitzhugh Carter area during the special September duck season.

**Permit, Stamp and License Requirements** - Quota permit (if hunting during any quota period), mobility-impaired certificate (if hunting in the mobility-impaired area unless accompanying a person possessing a mobility-impaired certificate), hunting license, management area permit, migratory bird permit and state waterfowl permit and federal duck stamp (if hunting waterfowl).

**Legal to Hunt** - See Migratory Bird Hunting Regulations pamphlet.

**Regulations Unique to Migratory Bird Seasons** - In addition to these regulations, all General Area Regulations and Migratory Bird Regulations shall apply.

1. Hunting duck, geese and coot with lead shot is prohibited
2. Centerfire shotguns are allowed for hunting during established area seasons when one or more migratory birds are legal to take.

#### **FISHING AND FROGGING:**

**Allowed year round** (except in the Fitzhugh Carter area - refer to the Fitzhugh Carter Tract brochure at [MyFWC.com](http://MyFWC.com) for specific regulations or call 850-265-3676 [TDD 800-955-8771] for a copy of this brochure).

**Permit, Stamp and License Requirements** - Fishing license (not required when frogging).

**Legal to Take** - See Florida Freshwater Fishing Regulations Summary.

**Regulations Unique to Fishing and Frogging** - All General Area Regulations and General Freshwater Fishing Regulations shall apply.

1. Anglers shall check in and out at the check station when entering and exiting the Fitzhugh Carter area and shall check all fish taken.
2. On all Fitzhugh Carter area lakes and water bodies, fishing is allowed only by permit issued by the Commission. Days and hours of operation, fish bag and size limits, angler quotas and other related rules shall be as designated by the Commission and posted at the check station.
3. Shooting frogs is allowed only during the listed open hunting seasons and only with the legal methods of take during each particular season.

#### **NORTHWEST FLORIDA WMD RULES AND INFORMATION:**

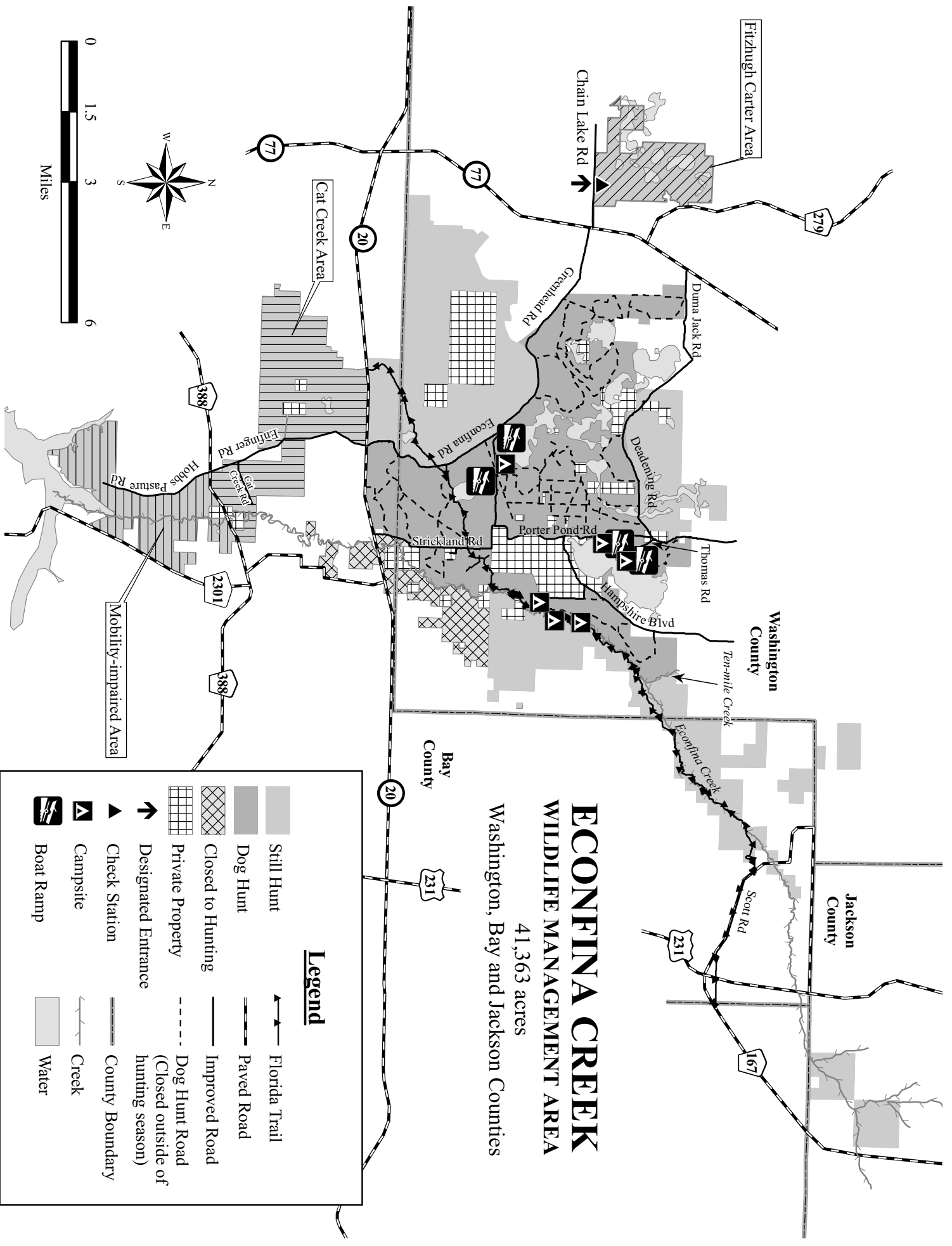
