

1st Annual Kayak & S U P fishing Tournament

As a participant in the S U P Fishing Tournament, I, on behalf of myself, my spouse, my children, my heirs, assigns, personal representative and estate or in my capacities as parent or guardian, hereby agree as follows:

1 I acknowledge that Stand Up Paddle Fishing entails known and unanticipated risk which could result in physical or emotional injury, paralysis, death or damage to myself, to property, or to third parties, I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. The risk included, among other things: Waves, swell, wind, tidal conditions and currents, travel to remote areas, collision with objects or watercraft, prolonged exposure to cold water, hypothermia, accidental drowning, mental anguish or trauma, illness in remote areas, exposure to sun, strong wind, cold, storms, large waves, eddies and whirlpools, lightning, aggressive and/or poisonous marine life, wrist, arm, hip, leg, knee, ankle, foot chest, shoulder and/or back injuries, slips and falls, and rapidly changing adverse weather and water conditions.

2 I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risk.

3 I hereby voluntarily, release, forever discharge and agree to indemnify and hold harmless the organizers, sponsors, volunteers and other participants (collectively, "Released Parties") of this event from any and all claims, demands, causes of action or liability, in law or in equity, that have arisen or may arise from any SUP activity or trip and that involve any damage, loss, or injury to me, my spouse, any of my children, my property, or the property of any of my children. In the same capacities, I promise not to sue any of the Released Parties for any such demands, claims, or liability. This waiver, release, indemnification, and promise not to sue do not apply to claims of criminal conduct or gross negligence.

4 I understand that the Released Parties may take photographs of me and my family in the course of SUP activities, and I grant permission to publish such photographs in a manner the Released Parties deem appropriate.

5 This **Activity Release Form** is in effect for events or activities that I, or any of my children, may participate in. This form is revocable, prospectively only, in writing signed by me that bears the date that the revocation is delivered to the organizers. If not revoked as stated herein, this form expires one (1) year after date of execution.

6 By signing this entry form, I acknowledge I have had sufficient opportunity to read this entire document. I have read and understand it, and I agree to be bound by its terms.
